I. COMPETITION OVERVIEW

The 2024 Potomac Open will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the <u>current rulebook</u>, as well as any pertinent updates that have been posted on the U.S. Figure Skating <u>website</u>.

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, a collegiate club or who is an individual member in accordance with the current rulebook. For non-U.S. citizens, please refer to the <u>rulebook</u> for more information.

U.S. Figure Skating Waivers are a requirement for ALL athletes. The online waivers must be completed via <u>Members Only</u> before the entry deadline.

III. REGISTRATION INFORMATION

ENTRIES WILL OPEN ON JUNE 12, 2024 at 12:01am ET.

Online registrations will be accepted via <u>EMS Competition Portal</u> and must be made by <u>credit card only</u>. Each transaction includes a non-refundable 3% transaction fee.

Entries will close at 11:59 PM EDT July 21, 2024

The LOC reserves the right to close at any time if maximum capacity is reached. Please register in a timely manner.

Late entries may be accepted if space allows. Late registration deadline is 11:59pm July 24, 2024 and will include a \$75 late fee.

Online registration will close at **11:59 PM EDT on July 21, 2024 (or sooner if capacity is reached).**

The competition committee also reserves the right to limit entries to any event, to combine event levels and to cancel any event. Late entries MAY be accepted at the discretion of the LOC and will require an additional late entry fee of \$75.

TEST CREDIT

Skaters who meet the requirements for test credit may sign up for Test Credit in EMS. **Test credit EMS availability will close at registration deadline**. There is a \$15 fee for the test credit packet. Please include your email. Signups will not be taken at the competition.

MUSIC

DEADLINE: August 7, 2024 at 11:59 pm ET.

Competitors must upload their music no later than **August 7**, **2024** at **11:59 pm ET**. After this date, skaters will be **locked** out of this feature and subject to a **\$25 late fee**. Music must be uploaded to the <u>EMS Competition Portal</u>. The late fee will automatically be added to each participant's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the credential(s) onsite. Any changes in music after the deadline will also incur the late fee.

All music must meet the following criteria. If you have questions about what format you have, please contact your coach and get a new version of your music that meets the criteria listed below.

MUSIC CRITERIA:

- File Format: MP3
- Bit Rate: 192 kbps or higher and Sample Rate: 44,100 kHz
 - o This will be verified by the music chair and they may request you upload a corrected file.
- Leaders and trailers (the silence or "dead space" before and after the actual start and end of the program music) may not exceed two (2) seconds. We prefer that there be NO leaders or trailers at all. Excessive leaders and trailers may disrupt the playing of the music during competition.

Competitors must also have available a backup copy of their competition music on a cell phone and it must be immediately available rinkside whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

PLANNED PROGRAM CONTENT (PPC) SUBMISSION for IJS events only.

All competitors participating in IJS events are required to submit PPC in <u>EMS</u> <u>Competition Portal</u> no later than **August 7**, **2024 at 11:59 PM EST**. After this date, skaters will be **locked** out of this feature in EMS and subject to a **\$25 late fee**. The late fee will automatically be added to each participant's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the credential(s) onsite.

REFUND POLICY

Entry fees will not be refunded after July 21, 2024, unless no competition exists or the event is canceled. There will be no refunds under any circumstances, including for medical withdrawals. The online credit card processing fees are not refundable. Contested credit card charges will be issued a \$25 fee. Payment of the fee will be required before the skater is allowed to participate in practice ice or events.

SCHEDULE

Events will be held on all days of the competition and competitors may be scheduled for any day or time of the announced dates of the competition (August 16, 17, or 18, 2024). The competition and practice ice schedule will be available via the <u>EMS</u> <u>Competition Portal</u> as soon as possible after the close of entries. All participants will be notified via email once available.

IV. COMPETITION DETAILS

FACILITY: Ashburn Ice House 21595 Smith Switch Road Ashburn, VA 20147 (703) 858-0300

The Ashburn Ice House is a two-rink facility, with both surfaces NHL size (200'x85') with events happening on both rinks. Both rinks have rounded corners and the temperature can be cold in the summer months.

LOCKER ROOMS AND CHANGING AREAS

Locker rooms and changing areas, **if any**, at U.S. Figure Skating competitive events are for athletes only, will be labeled with regard to specific use and where identified will be gender specific. An exception can be made for athletes 11 years old and younger that will allow for one parent of the same gender to assist their child immediately prior to and after their skating event(s). Please review the Locker Room and Changing Area Policy and the SkateSafe Handbook (both found on the <u>U.S.</u> <u>Figure Skating SkateSafe</u> page).

OFFICIAL WEBSITE AND UPDATES

An official bulletin board will be maintained in the rink near registration for competition notifications such as schedule modifications. **Skating orders and event results will be posted online only.** The link to starting orders and results will be available on the competition website and onsite at the event. It is the responsibility of each competitor and coach to check the bulletin board for any schedule changes and/or additional information. A tentative schedule of events will be posted online prior to the competition. Please do not arrive late or it may affect your ability to participate in your event. Event results will be posted online.

SCHEDULE AND OFFICIAL NOTICES

Competitors may be scheduled at any day or time during the announced dates of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available.

The overall competition schedule is as follows:

•	Friday, August 16, 2024	8:00AM - 10:30PM
•	Saturday, August 17, 2024	6:00AM - 10:00PM
•	Sunday, August 18, 2024	6:00AM - 3:00PM

All times are in Eastern Standard Time (EST). As soon as possible after the close of entries, the schedule will be available at <u>your</u> skater portal. Please check for changes to the schedule periodically. The LOC does not assume responsibility for changes in travel plans that may result from schedule changes.

Once the competition begins, the online schedule may no longer be valid and skaters should check for changes in events and times, which will be posted at registration. Skaters should check in with the ice monitor of their event between 30 and 60 minutes prior to the scheduled start time of their event. Events may start either *earlier or later* than originally scheduled.

ONSITE CHECK-IN: Registration will begin on **Friday, August 16, 2024**

approximately one hour prior to the start of events and will remain open throughout the competition. The registration table will be located in the lobby of the Ashburn Ice House. Please register promptly upon arrival. If you are participating in a role requiring compliance, please be sure to <u>download or print your compliance card</u> to verify your compliance status on-site, if requested. If you believe your compliance card does not accurately reflect your compliance status, please contact skatesafe@usfigureskating.org at least 2 business days prior to the competition for assistance.

PRACTICE ICE

Unofficial practice ice will be available for purchase online through the <u>EMS</u> <u>Competition Portal</u>. A timeline for practice ice sales periods will be available for viewing on the Main page of your skater portal. The length and number of practice ice sessions will be determined after the event schedule is set. Practice will be 15 minutes or more depending on the schedule. Longer practice sessions are at the discretion of the chief referee and may be in less desirable time slots.

At the time of registration, each skater will be able to reserve and purchase one session per event entered at \$20 per session and will be able to select the date and time from the published practice ice schedule <u>after the close of registration</u>. Some sessions will be restricted to certain events. As soon as the schedule is posted, you will receive an email with the start date and time for reserved unofficial practice ice selection.

After the end time of reserved selection, unofficial practice ice will be open to all entrants for \$25 per session. Additional ice may also be available for purchase during the competition for \$25 per session.

There will be no official practice ice scheduled.

No program music will be played during practice ice sessions.

AWARDS

Medals for 1st, 2nd, 3rd and 4th places will be presented in all events with 2 competitors or more who skate their programs. Award ceremonies will be held at the arena and times will be posted at registration.

PHOTOGRAPHY/VIDEOGRAPHY

Video is included in the registration fee. Professional video is provided by Looking Glass Productions, and information for downloading the video will be sent out after the competition. There will be no livestream.

Action photos by Melanie Heaney Photography are provided for an additional fee. Skaters will receive an email about pre-orders before the competition.

Spectators are reminded that flash photography is dangerous to skaters and is strictly prohibited. Personal video cameras are permitted but may only be used to film your skater's performance and for personal use only. Only hand held video units are allowed; electrical cords, tripods (or similar devices) are not permitted in the arena. PERSONAL VIDEO FILMING IS ONLY PERMITTED FROM THE AUDIENCE STANDS. FILMING FROM THE COACHING AREA OR HOCKEY BOXES IS NOT ALLOWED.

Note, per U.S. Figure Skating policy, photographing and/or recording of any one other than your own skater is strictly prohibited.
